TO QUALIFY FOR THIS SCHOLARSHIP, YOU MUST BE A GRADUATE FROM COUDERSPORT HIGH SCHOOL AND ACCEPTED INTO A POST-SECONDARY PROGRAM IN THE STATE OF PA. SELECTION IS NOT BASED ON GRADE POINT AVERAGE, BUT SOMEONE WHO WORKS HARD AND HAS PROVEN TO BE SUCCESSFUL.

For consideration this application must be completed and returned to the guidance office by

MARCH 26, 2018. All Staiger Scholarship applications must be received at the Community Foundation of North Central PA no later than April 1. There will be no exceptions. The Scholarship Selection Committee, appointed by the Board of Trustees of the Community Foundation will select the scholarship recipient.

Staiger Scholarship Fund

Gene "Toots" Staiger graduated from Coudersport Area High School in 1965 and was very active in high school and in his community. His career and volunteer involvement saw him as a teacher, member and President of Borough Council, involved in the Jaycees, Fire Department, ambulance services and executive director of the McKean County Assistance Office. He established this perpetual scholarship to give back to the community and current students by providing support that will educate Coudersport's future leaders. The Staiger Scholarship Fund was established at the Community Foundation of North Central PA in 2016 and is designed to help, encourage and support students that are active in their community and demonstrate financial need and are attending a 2 or 4-year post-secondary education program. Students must be a graduating senior from Coudersport High School.

TERMS FOR SCHOLARSHIP

The committee will grant the **Gene "Toots" Staiger Scholarship** as instructed. The selection of a student to receive the scholarship shall be made by the committee without regard to race, religion or sex of the applicants or their political or economic perspectives. The committee will not place restrictions upon a candidate's choice of college or university, except that it must be a PA school.

The committee shall require, prior to the disbursement of any scholarship, proof that the scholarship recipient is actually enrolled as a student at the educational institution for which the grant is made, and all scholarship grants shall be paid only to the education institution attended by the recipient and never directly to the recipient. This grant covers tuition, fees, and books for the applicable fall, winter, or spring quarter.

The Community Foundation of North Central PA is approved as a PATH Program participant.

If you are awarded a scholarship of at least \$500 from the Community Foundation we will submit your name to AES/PHEAA for additional scholarship funding through PATH. To be eligible for the PATH award, you must meet the following criteria: be enrolled in an approved Pennsylvania College or career school; be a State Grant recipient and have a Federal Student Loan; and demonstrate financial need for PATH Program Grant. PATH grants will not exceed the Maximum State Grant for the particular academic year.
